A first reading of a By-law for the address ejection during last was approved. Item will move to the August Meeting of the Athletic Board for a second Reading.

The League Admission Policy was modified with a \$1.00 increase in admission in every category. This becomes effective in August 2014

A proposal to have a League Dinner prior to each sport season was approved. Responsibility for hosting the event will be rotated among the schools, however Jason Feuerbach will secure the Rocklin Event Center for each dinner. For next year the hosts will be:

Whitney – Fall Sports - August Roseville – Winter Sports - November Bella Vista – Spring Sports - February

The Athletic Directors will plan the format for the Dinners at the May AD meeting.

By a final vote of 5-1 it was decided to play varsity only games on Friday nights. Sub varsity games will be played as part of a double header on Thursday nights.

Starting times for varsity games will be 7:00 Freshman games will start at 4:00 with Sophomore games to be at 6:00 This policy will not apply to non-league games. Schools will have their choice of when games will be played.
