NEW BUSINESS

Three by-law changes requested by the baseball coaches (First Readings)

1. By-Law change in baseball to eliminate Saturday as a mandatory make up day. Approved for a second reading at the October Meeting.

2. Delete By-law 10.2.1 (Failure of a team to play on the next available date

results in a forfeit.) This item was retired for lack of a motion.

3. Adopt a new tie breaking by-law: In case of a three way tie for the last qualifying spot, a coin flip would determine which team would receive a bye. The remaining two teams would play one game. The winner of that game would play the bye team. Approved for a second reading at the October Meeting.

Request from Volleyball coaches (Boys and Girls) to establish a by-law to address a tie for the final qualifying spot was approved as a first reading and will be heard as a second reading the October Meeting.

1. Two teams tie for the final qualifying spot and the tie cannot be broken by head to head competition. A two out of three set game will be played between the two tied teams at a neutral site.

2. Three teams tie for the final spot: All teams would meet at a neutral site. A coin toss will determine the bye team. The remaining teams will play a two out of three set game. The losing team is eliminated. The winning team plays the bye team in a two out of three game, with the winner advancing.

3. These matches must occur before the CIF Section last contest date. All of the matches would be on the same day.

The Water Polo Schedule will continue on a Tuesday, Thursday schedule. If there is a problem with assigning officials on those days, schools will be required to move their games to a Monday or Wednesday.
