## OLD BUSINESS

A Second Reading of a proposal to change to All Conference by-laws in each sport using the slotted formula pass unanimously. All appropriate sections in the constitution will be changed.

## NEW BUSINESS

A First Reading proposal to change Wrestling by-laws to include dual meet win and league meet in in determining the league championship passed unanimously.

A discussion of how to handle no shows for league dinners League Dinners resulted in no change. ADs promised to monitor their coaches better.

It was decided that all schedules for next year for next year, except football, would remain as they have been for four years, only the home and away would be switched. The commissioner was directed to prepare four potential football schedules, one where the first game was moved to the last game, one where the last game we moved to the first game, the current format with home and away changing and a completely new schedule where schools could draw numbers for their position on the schedule. The four schedules will be voted on electronically.

A unanimous vote to allow the commissioner to Remove all by laws relating to change of classification and refer to the Section rule.

The Board approved by unanimous vote to change the CVC classification policy. Effective at the start of winter sports, divisions will be Frosh/Soph, JV and Varsity.
